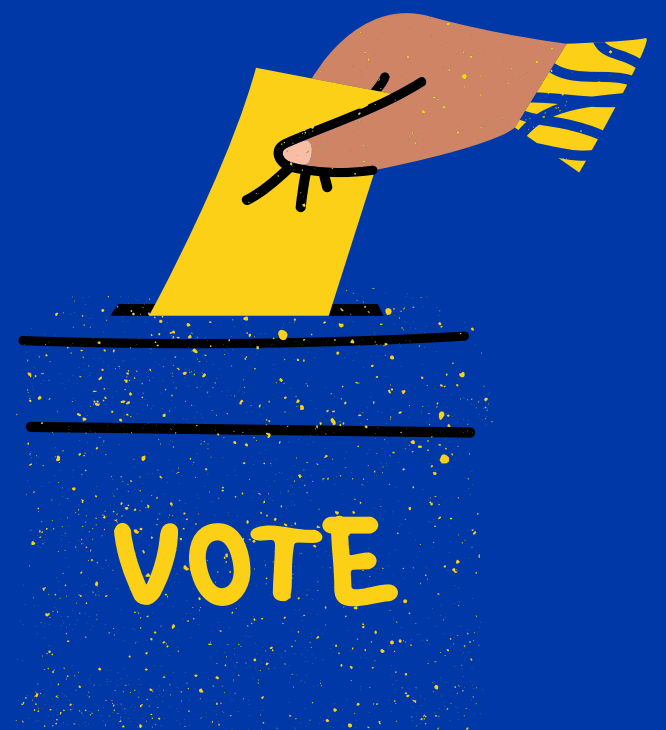

There are three (3) open positions for Board members, and we have three (3) candidates running for the board - you can also write in a candidate if you want. PLEASE make sure you vote – even though it seems each candidate will be elected, we need to have at least 20% of owners vote in the election, or we will need to redo the election.

IN-PERSON VOTING

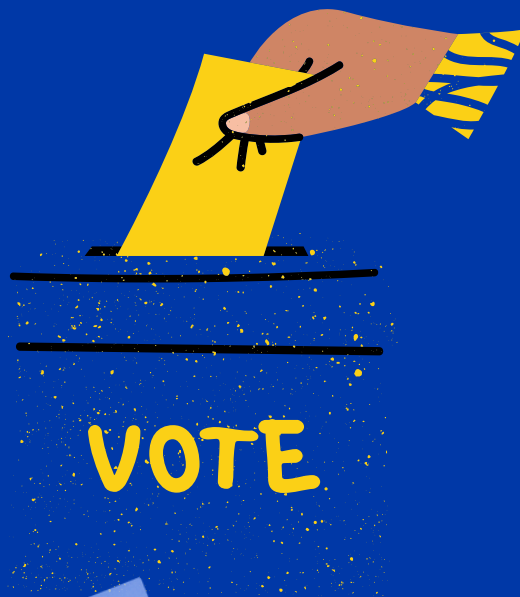
- Voting begins on February 1, 2026.
- Your ballot will be mailed to your current address.
- There is only one (1) vote per home.
- Only owners are allowed to vote in the election.
- If you are in arrears on your assessment or owe money for fines, you will not receive a ballot until paid in full; please contact the office if you have any questions.
- All ballots will be mailed with a return envelope marked BALLOT. The ballot MUST be returned in this envelope, and it must be sealed. Any ballot received not sealed or in the correct envelope will not be counted.
- You can either drop your ballot in the ballot box at the office during business hours, drop it into the locked mailbox near the front door of the Clubhouse, or mail it to the office.
- All ballots must be returned by Tuesday, February 24, 2026, by 8:00 pm to be counted.

ABSENTEE VOTING

For those who will be out of town the whole month of February, you must complete the Request for Absentee Ballot form and return it to the office by January 28th. The Request form is available in the office, on the website, and is included in this email.

- Redesigned the Clubhouse entrance signs, planted new flowers, and installed energy-efficient LED lights.
- Installed a new fountain in the pool area garden.
- Planted variegated bushes by the stairs leading to the Clubhouse.
- Replaced dead trees with 6 to 8-foot replacements.
- Swapped heavy wooden doors for a sliding glass door at the Clubhouse entrance for a clear view of the pool.
- Decorated the Clubhouse with orange lights and an 8-foot inflatable pumpkin for Halloween and Thanksgiving.
- Replaced rotting plywood with faux stone siding at the entrance.
- Remodeled the kitchen using rebates, with no funds from operating or reserve accounts.
